

2007-08 GYMNASTICS PLUS TEAM POLICY

A. PARENTAL RESPONSIBILITIES

Transportation to and from practice and meets, timely payments of monthly fees, custodial account and meet expense fees, to work or provide an adult worker for the state invitational, and participate in the one required Booster Club fund raiser. To provide a positive influence/attitude to your daughter in regards to practice and competition, to refrain from communication and or "coaching" your daughter during practice and meets.

B. GYMNASTS RESPONSIBILITIES

Attend all practices and give 100% effort in each practice, be properly dressed and ready to practice at **given starting time**, (no shirts, sweats, gum), attend all meets, and call the gym prior to practice if sick or can not attend.

C. TEAM FEES

Team fees are budgeted on a yearly basis and broken into 12 equal payments. If vacation time is taken there will be no prorating of fees. Team fees are always due **IN HAND** by the 7th of the month. Checks received the 8th or later will be assessed a \$10.00 late fee. If late fee is not included in check amount it will be deducted from your custodial account. If you need to arrange a different due date contact NANCY. You may also pay with a Visa/MasterCard either monthly or keep the # on file at the gym.

All monthly team fee checks are to be separate from other payments.

Yearly Registration Fee:	\$15.00/yr. to be paid with Sept's fee.

D. HOURS FOR THE SCHOOL YEAR

Level 4 Team- Tue and Thurs 4:00-6:30

Level 5, 6 - Tuesday & Thursday - 5:45-9:00 and Saturday- 10:00-1:00

Level 7-9 - Monday & Wednesday- 5:45-9:00, Friday 4:00-6:30 and
Saturday 12:30-3:45

E. MAKE UP TIME

All make ups will be dealt with individually. You may not just show up at a practice for a make up. You may only schedule 1 make up per week. Please schedule through Ed or Nancy only.

F. CUSTODIAL ACCOUNT

All meet entries are paid through a custodial account. Compulsory meets will cost approximately \$35-\$50. Optional meets will cost approximately \$75-\$100. For compulsory gymnasts a \$200 initial input and a \$150 balance is required to be in your account. For optional gymnasts a \$250 initial input and a \$200 balance is required to be in your account. Monthly statements will be sent out regarding your balance. Custodial checks must be separate from other payments due. Your check will be returned if not separate and late fees could occur. Checks are to be made to Gymnastics Plus. The initial amounts need to be in your account by 8/18/07. ***Important*** If your account is negative or at \$0 you will not be entered into any meets.

G. MEET EXPENSES

Meet expenses include coaching fees, gas used, tolls, meals, hotel, car rental, airfare, etc. These expenses are paid through the Booster Club. The fees are \$225.00. This fee is due by Sept. 1. You have the opportunity to have the full amount reimbursed in Dec. by fundraising. Please refer to the Booster Club handout for detailed information. Please place these fees in a separate envelope marked for the Booster Club Treasurer. Make checks payable to Gymnastics Plus Booster Club. Failure to be current with these fees may jeopardize your daughters competitive eligibility.

H. ATTENDANCE

Attendance is extremely important. As it is we go many less hours than other clubs. The only way to be successful at the highest level attainable is to be at practice all the time, and to have a high level of productivity each practice. Only 1 make up per week is allowed. Your practice schedule **WILL NOT** be changed except for religious classes.

You must attend a minimum of 3 meets prior to your state meet to be eligible to compete in your state meet. You may not miss the practice before a meet unless approved by Ed or Nancy.

I. MEETS

Unless otherwise notified **IN WRITING** 60 days prior to a scheduled meet we expect the girls to go to all the meets scheduled. The importance of you notifying us is a financial one. Most meet fees are due 6-8 weeks prior to a meet, so if we are not notified **IN WRITING** before the meet entry goes in, you will lose the entry fee. *All notes should be dropped in payment box or e mailed to NANCY.* Once an entry fee is paid there are **NO REFUNDS** regardless of injury, illness, weather, etc. Girls should be at the meet site 15 min. before bar set times. All girls must stay on the meet floor and may not leave without coaches permission. Parents are **NOT** allowed on the competition floor under any circumstances. Parents are **NOT** allowed to approach the scoring table and or judges at any time. All team members must stay in team uniform until after awards. All team members must sit together during awards. Gymnasts may **NOT** sit with their parents during awards. Awards may only be accepted in leotard and or warm up. (No T-shirts allowed).

If you have any problems, concerns and or questions, please call or E mail us. It is NOT appropriate to air concerns in the parents observation area. All concerns and questions need to be addressed to Ed or Nancy. Please **DO NOT** try to talk or call the coaches during class times. **Parents are NOT welcome to come upstairs or into the gym past the mailboxes at any time for ANY reason.** The best time to reach us is during the day before 3:30 or E mail at judgen1@aol. (Nancy) or freded8@aol. (Ed). Please try to come into the gym at least once a week to see if anything new has been posted on the bulletin board. Have the girls check their mailbox's at every practice. All mailbox and posted materials are on the web site. Please try to check it often. GymPlus.org click on Booster Club link located on bottom left of page.
